

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution Nos. 32-80, 99-039, 2000-397, 02-241, 02-280,
02-508, 03-057, 03-280, 03-301, 04-109, 05-472 and 07-362 to Correct Names
of Enrolled Members and/or Enrollment Numbers)

RESOLUTION NO. 20-004

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws
2 and ordinances governing the enrollment and adoption of members (Article II,
3 Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono
4 O'odham Nation); and

5 **WHEREAS,** Articles VI and VII of the Nation's Enrollment Ordinance provide that the
6 Enrollment Committee is responsible for reviewing enrollment applications and
7 making recommendations to the Legislative Council regarding the eligibility of
8 applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and

9 **WHEREAS,** Article VIII of the Nation's Enrollment Ordinance provides that the Tohono
10 O'odham Legislative Council shall determine whether an application is approved
11 for membership and its determination, along with the resolution number and
12 date of enactment, shall be provided to the applicant; and

13 **WHEREAS,** the Enrollment Program has determined that a number of resolutions approving
14 membership and adoption applications misspelled or incorrectly listed the
15 names of members and/or incorrectly listed enrollment numbers; and

16 **WHEREAS,** the Enrollment Program therefore recommends that Resolution Nos. 32-80, 99-
17 039, 2000-397, 02-241, 02-280, 02-508, 03-057, 03-280, 03-301, 04-109, 05-472 and
18 07-362 be amended to reflect the correct name and/or enrollment numbers for
19 the members identified in the January 2020 Corrected Enrollment Resolution
20 Summary, which is incorporated by this reference.

21 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution
22 Nos. 32-80, 99-039, 2000-397, 02-241, 02-280, 02-508, 03-057, 03-280, 03-301, 04-
23 109, 05-472 and 07-362 are amended upon the effective date of those resolutions
24 to reflect the correct name and/or enrollment number for the members
25 identified in the January 2020 Corrected Enrollment Resolution Summary.

26 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH
27 day of JANUARY, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-
28 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by
29 Article II, Section 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono O'odham
30 Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting
31 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
32 16 of the Act of June 18, 1934 (48 Stat.984).
