

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2020 San Lucy District Community, and Maintenance and Diabetes**  
**Departments Budget Amendment No. 1)**

**RESOLUTION NO. 20-007**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only  
6 by a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

11 ; and

12 **WHEREAS,** the FY 2020 San Lucy District Budget in the amount of \$11,864,798.39 was  
13 authorized by San Lucy District Resolution No. SL 08-205-19 and approved by  
14 Legislative Council Resolution No. 19-357; and

15 **WHEREAS,** the San Lucy District Council has authorized:

- 16 (1) by Resolution No. SL 10-259-19, the FY 2020 San Lucy District Community  
17 Budget Amendment No. 1;  
18 (2) by Resolution No. SL 10-260-19, the FY 2020 San Lucy District Maintenance  
19 Department Budget Amendment No. 1; and  
20 (3) by Resolution No. SL 10-261-19, the FY 2020 San Lucy District Diabetes  
21 Department Budget Amendment No. 1, all of which are incorporated by these  
22 references and all of which adjust operational and/or personnel line items;  
23 and

24 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2020 San Lucy District  
25 Community, and Maintenance and Diabetes Departments Budget Amendments  
26 No. 1 and recommends their approval.

27 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves:

- 28 (1) the FY 2020 San Lucy District Community Budget Amendment No. 1, which  
29 includes a \$872,881.53 increase from \$4,400,000.00 to \$5,272,881.53 that  
30 shall be funded by FY 2019 San Lucy District Community Budget carry over  
31 funds;  
32 (2) the FY 2020 San Lucy District Maintenance Department Budget  
33 Amendment No. 1, which includes a \$45,191.00 increase from


**BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2020 San Lucy District Community Budget as amended shall be managed and expended in accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup> day of JANUARY, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article XI, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


