

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Appropriating a One-Time \$15,000 Sponsorship for
Miss Indian Rodeo Queen)

RESOLUTION NO. 20-008

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, Tohono O'odham Nation member Oriana Lopez competed for and was selected**
8 **the Miss Indian Rodeo Queen for the 2020 rodeo season; and**

9 **WHEREAS, the Natural Resources Department is requesting a one-time sponsorship in the**
10 **amount of \$15,000.00 to support Ms. Lopez to meet her Miss Indian Rodeo Queen**
11 **tour obligations during the 2020 rodeo season including travel throughout the**
12 **United States and First Nations of Canada, and other related expenses; and**

13 **WHEREAS, the Natural Resources Department has prepared and submitted for review its FY**
14 **2020 Natural Resources Department Miss Indian Rodeo Queen Sponsorship**
15 **Budget, which is incorporated by this reference, in the amount of \$15,000.00; and**

16 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
17 **have reviewed the FY 2020 Miss Indian Rodeo Queen Sponsorship Budget and**
18 **Recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2020 Natural Resources Department Miss Indian Rodeo Queen Sponsorship**
21 **Budget, which includes a one-time appropriation of \$15,000.00 that shall be**
22 **funded by the Nation's general fund.**

23 **NOW, THEREFORE, BE IT FURTHER RESOLVED that the Miss Indian Rodeo Queen will be**
24 **required to provide quarterly financial reports to the Office of the Chairman and**
25 **Vice Chairwoman and the Agricultural and Natural Resources Committee, and a**
26 **final report on finances and activities in October 2020, the final month of her**
27 **reign as Miss Indian Rodeo Queen to the Office of the Chairman and Vice**
28 **Chairwoman and the Agricultural and Natural Resources Committee.**


29 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
30 **Nation chairperson or any designated official is authorized to administer and**
31 **expend the FY 2020 Miss Indian Rodeo Queen Sponsorship Budget, provided that**
32 **any amendments or modifications shall be submitted for prior approval by the**
33 **Tohono O'odham Legislative Council.**


