

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Department of Public Safety Fire Department
Budget Amendment No. 1)

RESOLUTION NO. 20-009

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2020 Department of Public Safety Fire Department Budget in the amount**
8 **of \$5,060,957.18 was approved by Resolution No. 19-323; and**

9 **WHEREAS, the Department of Public Safety has prepared and submitted for review and**
10 **approval its FY 2020 Fire Department Budget Amendment No. 1, which is**
11 **incorporated by this reference and which will adjust operational and/or**
12 **personnel line items; and**

13 **WHEREAS, the FY 2020 Department of Public Safety Fire Department Budget Amendment No.**
14 **1 will not change the original budget amount of \$5,060,957.18; and**

15 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**
16 **2020 Department of Public Safety Fire Department Budget Amendment No. 1 and**
17 **recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2020 Department of Public Safety Fire Department Budget Amendment No. 1**
20 **effective October 1, 2019, which does not change the total budget amount.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
22 **Nation chairperson or any designated official is authorized to administer and**
23 **expend the FY 2020 Department of Public Safety Fire Department Budget as**
24 **amended, provided that any amendments or modifications shall be submitted**
25 **for prior approval by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
27 **day of JANUARY, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
29 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat.984).**
