

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Appointment of Jerry Derrick as Executive Director of the Gaming Office)

RESOLUTION NO. 20-010

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Nation's chairperson**
2 **with authority to appoint the Nation's treasurer, and other officers and heads of**
3 **all governmental departments with the approval of the Tohono O'odham**
4 **Legislative Council (Constitution, Article VII, Section 2(e)); and**
5 **WHEREAS, Chairman Ned Norris, Jr. has appointed Jerry Derrick as the Executive Director of**
6 **the Gaming Office, subject to the approval of the Legislative Council; and**
7 **WHEREAS, 1 T.O.C. Chapter 4 and 16 T.O.C. Chapter 1, Section 402, establish background**
8 **investigation, criminal history review, and other requirements for the**
9 **appointment of the Executive Director of the Gaming Office, and specifies that the**
10 **appointment must be approved by majority vote of the Legislative Council; and**
11 **WHEREAS, pursuant to Article III, Section 6(B) of the Legislative Rules of the Tohono**
12 **O'odham Legislative Council, the chairperson's "appointee to the position of**
13 **treasurer or other officers or heads of governmental departments shall not be**
14 **added to any Legislative Council session agenda for approval unless the**
15 **appropriate legislative committee interviews the appointee after receiving a**
16 **resume and written background investigation report" containing detailed**
17 **employment, education, credit, litigation, and other information necessary to**
18 **determine the appointee's qualifications and fitness; and**
19 **WHEREAS, the Legislative Commerce Committee has received and reviewed the detailed**
20 **written background investigation report required by the Legislative Rules, 16**
21 **T.O.C. Chapter 1, Section 402, and 1 T.O.C. Chapter 4, interviewed the appointee,**
22 **and recommends that the Legislative Council approve the appointment.**
23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
24 **appointment of Jerry Derrick as Executive Director of the Gaming Office.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
26 **day of JANUARY, 2020 at a meeting at which a quorum was present with a vote of 2,116.0 FOR;**
27 **1,059.7 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council**
28 **by Article VII, Section 2(e) of the Constitution of the Tohono O'odham Nation, adopted by the**
29 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat.984).**
