

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Appointment of Theoria Campillo as Nation's Chief Administrative Officer)

RESOLUTION NO. 20-011

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Nation's chairperson**
2 **with authority to appoint the Nation's treasurer, and other officers and heads of**
3 **all governmental departments with the approval of the Tohono O'odham**
4 **Legislative Council (Constitution, Article VII, Section 2(e)); and**

5 **WHEREAS, the Nation's Chairman Ned Norris, Jr. has appointed Theoria Campillo as the**
6 **Nation's chief administrative officer, subject to the approval of the Legislative**
7 **Council; and**

8 **WHEREAS, the Appointed Officers law, 1 T.O.C. Chapter 4, establishes the process for review**
9 **of appointments by the appropriate oversight committee and the Council, and**
10 **the documents required, including copies of the current job description, the**
11 **appointee's current resume, contact information, and current written**
12 **background investigation report; and**

13 **WHEREAS, pursuant to Article III, Section 6(B) of the Legislative Rules of the Tohono**
14 **O'odham Legislative Council, the chairperson's "appointee to the position of**
15 **treasurer or other officers or heads of governmental departments shall not be**
16 **added to any Legislative Council session agenda for approval unless the**
17 **appropriate legislative committee interviews the appointee after receiving a**
18 **resume and written background investigation report" containing detailed**
19 **employment, education, credit, litigation, and other information necessary to**
20 **determine the appointee's qualifications and fitness; and**

21 **WHEREAS, the Legislative Council Budget and Finance Committee has received and**
22 **reviewed the detailed written background investigation report, interviewed the**
23 **appointee, and recommends that the Legislative Council approve the**
24 **appointment.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
26 **appointment of Theoria Campillo as the Nation's chief administrative officer.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
28 **day of JANUARY, 2020 at a meeting at which a quorum was present with a vote of 2,720.3 FOR;**
29 **455.4 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council**
30 **by Article VII, Section 2(e) of the Constitution of the Tohono O'odham Nation, adopted by the**
31 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**
