

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Appointment of Ryan Claw as Nation's Treasurer)

RESOLUTION NO. 20-012

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Nation's chairperson**
2 **with authority to appoint the Nation's treasurer, and other officers and heads of**
3 **all governmental departments with the approval of the Tohono O'odham**
4 **Legislative Council (Constitution, Article VII, Section 2(e)); and**

5 **WHEREAS, the Nation's Chairman Ned Norris, Jr. has appointed Ryan Claw as the Nation's**
6 **treasurer, subject to the approval of the Legislative Council; and**

7 **WHEREAS, the Appointed Officers law, 1 T.O.C. Chapter 4, establishes the process for review**
8 **of appointments by the appropriate oversight committee and the Council and the**
9 **documents required, including copies of the current job description, the**
10 **appointee's current resume, contact information, and current written**
11 **background investigation report; and**

12 **WHEREAS, pursuant to Article III, Section 6(B) of the Legislative Rules of the Tohono**
13 **O'odham Legislative Council, the chairperson's "appointee to the position of**
14 **treasurer or other officers or heads of governmental departments shall not be**
15 **added to any Legislative Council session agenda for approval unless the**
16 **appropriate legislative committee interviews the appointee after receiving a**
17 **resume and written background investigation report" containing detailed**
18 **employment, education, credit, litigation, and other information necessary to**
19 **determine the appointee's qualifications and fitness; and**

20 **WHEREAS, the Legislative Council Budget and Finance Committee has received and**
21 **reviewed the detailed written background investigation report, interviewed the**
22 **appointee, and recommends that the Legislative Council approve the**
23 **appointment.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
25 **appointment of Ryan Claw as the Nation's treasurer.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
27 **day of JANUARY, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
29 **Article VII, Section 2(e) of the Constitution of the Tohono O'odham Nation, adopted by the**
30 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat.984).**
