

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2020 Department of Health and Human Services Bureau of Indian Affairs Family Preservation Program Budget Amendment No. 1)**

**RESOLUTION NO. 20-019**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d) (2)); and

7 **WHEREAS,** the FY 2020 Department of Health and Human Services Bureau of Indian Affairs  
8 ("BIA") Family Preservation Program Budget in the amount of \$234,849.00 was  
9 approved by Resolution No. 19-300; and

10 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for  
11 review and approval its FY 2020 BIA Family Preservation Program Budget  
12 Amendment No. 1, which is incorporated by this reference and which will adjust  
13 operational and/or personnel line items; and

14 **WHEREAS,** the FY 2020 Department of Health and Human Services BIA Family Preservation  
15 Program Budget Amendment No. 1 will increase the FY 2020 BIA Family  
16 Preservation Program Budget by \$37,989.50 from \$234,849.00 to \$272,838.50; and

17 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
18 reviewed the FY 2020 Department of Health and Human Services BIA Family  
19 Preservation Program Budget Amendment No. 1 and recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
21 FY 2020 Department of Health and Human Services BIA Family Preservation  
22 Program Budget Amendment No. 1 in the amount of \$272,838.50 that shall be  
23 funded by the Nation's general fund pending reimbursement from the grantor,  
24 Bureau of Indian Affairs.

25 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
26 Nation chairperson or any designated official is authorized to administer and  
27 expend the FY 2020 Department of Health and Human Services BIA Family  
28 Preservation Program Budget as amended, provided that any amendments or  
29 modifications shall be submitted for prior approval by the Tohono O'odham  
30 Legislative Council.


