

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Planning and Economic Development Department Roads
Program Project PIR 21(4) Santa Cruz to Papago Farms Budget Amendment No. 1)**

RESOLUTION NO. 20-033

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(3)); and**

7 **WHEREAS, the FY 2020 Planning and Economic Development Department Roads Program**
8 **Project PIR 21(4) Santa Cruz to Papago Farms Budget in the amount of**
9 **\$8,440,000.00 was approved by Resolution No. 19-342; and**

10 **WHEREAS, the Planning and Economic Development Department Roads Program has**
11 **prepared and submitted for review and approval its FY 2020 Planning and**
12 **Economic Development Department Roads Program Project PIR 21(4) Santa Cruz**
13 **to Papago Farms Budget Amendment No. 1, which is incorporated by this**
14 **reference and which will adjust operational and/or personnel line items; and**

15 **WHEREAS, the FY 2020 Planning and Economic Development Department Roads Program**
16 **Project PIR 21(4) Santa Cruz to Papago Farms Budget Amendment No. 1 will**
17 **increase the FY 2020 Planning and Economic Development Department Roads**
18 **Program Project PIR 21(4) Santa Cruz to Papago Farms Budget by \$1,138,368.09**
19 **from \$8,440,000.00 to \$9,578,368.09; and**

20 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
21 **have reviewed the FY 2020 Planning and Economic Development Department**
22 **Roads Program Project PIR 21(4) Santa Cruz to Papago Farms Budget Amendment**
23 **No. 1 and recommend its approval.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
25 **FY 2020 Planning and Economic Development Department Roads Program**
26 **Project PIR 21(4) Santa Cruz to Papago Farms Budget Amendment No. 1 effective**
27 **October 1, 2019, which includes a \$1,138,368.09 increase from \$8,440,000.00 to**
28 **\$9,578,368.09 that shall be funded by the Bureau of Indian Affairs.**

29 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
30 **Nation chairperson or any designated official is authorized to administer and**
31 **expend the FY 2020 Planning and Economic Development Department Roads**
32 **Program Project PIR 21(4) Santa Cruz to Papago Farms Budget as amended,**
33 **provided that any amendments or modifications shall be submitted for prior**
34 **approval by the Tohono O'odham Legislative Council.**
