RESOLUTION NO. 20-039

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Article VI,**
3 **Section 1 (h) of the Constitution of the Tohono O'odham Nation); and**

4 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
5 **Enrollment Committee is responsible for reviewing enrollment applications and**
6 **making recommendations to the Legislative Council regarding the eligibility of**
7 **applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

8 **WHEREAS, the Enrollment Program has determined that members were originally approved**
9 **for membership by Resolution Nos. 76-83 & 115-82; and**

10 **WHEREAS, the Enrollment Program discovered that the same members were mistakenly**
11 **approved a second time for membership by Resolution Nos. 76-83, 84-83 & 128-83,**
12 **165-83, 185-83, 07-84, 40-84; and**

13 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 76-83, 84-**
14 **83 & 128-83, 165-83, 185-83, 07-84, 40-84 be amended to delete the members**
15 **identified in the attached Amending Enrollment Resolution List February 2020;**
16 **and**

17 **WHEREAS, the Enrollment Program has identified a number of resolutions approving**
18 **members that misspelled or incorrectly listed the names of members and/or**
19 **incorrectly listed enrollment numbers; and**

20 **WHEREAS, the members that were originally approved in Resolution Nos. 76-83 & 115-82 will**
21 **retain the enrollment numbers and approval dates identified in the attached**
22 **Amending Enrollment Resolution List February 2020.**

23 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
24 **Nos. 76-83, 84-83, & 128-83, 165-83, 185-83, 07-84, 40-84 are amended upon**
25 **effective date of that resolution by deleting the members and corresponding**
26 **information identified in the attached Amending Enrollment Resolution List**
27 **February 2020.**
