

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting the United States Department of Justice Office of Justice Programs
Enhancement of the Tohono O'odham Nation Police Department's SORNA
Program No Cost Extension, Award No. 2017-AW-BX-0049 and Approving the
FY 2020 Budget)**

RESOLUTION NO. 20-053

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Public Safety applied for and was awarded the United States
8 ("U.S.") Department of Justice ("DOJ"), Office of Justice Programs ("OJP")
9 Enhancement of the Tohono O'odham Nation Police Department's SORNA
10 Program Award No. 2017-AW-BX-0049 in the amount of \$298,077.00 with effective
11 dates of October 1, 2017 through September 30, 2019, which was accepted and
12 approved by Resolution No. 18-090; and

13 **WHEREAS,** the Department of Public Safety applied for and was awarded a no cost extension
14 of Award No. 2017-AW-BX-0049 effective October 1, 2019 through September 30,
15 2020; and

16 **WHEREAS,** the Department of Public Safety has prepared and submitted for review and
17 approval its FY 2020 Department of Public Safety U.S. Department of Justice
18 SORNA Program Budget in the amount of \$160,354.98, which is incorporated by
19 this reference and which shall be funded by the Nation's general fund pending
20 reimbursement by the grantor, the U.S. Department of Justice, Office of Justice
21 Programs; and

22 **WHEREAS,** the Domestic Affairs and Budget and Finance Committees have reviewed the FY
23 2020 Department of Public Safety U.S. Department of Justice SORNA Program
24 Budget and recommend its approval.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council accepts the
26 no cost extension of the U.S. Department of Justice Office of Justice Programs
27 Enhancement of the Tohono O'odham Nation Police Department's SORNA
28 Program Award No. 2017-AW-BX-0049 effective October 1, 2019 through
29 September 30, 2020.

30 **BE IT FURTHER RESOLVED** that the Tohono O'odham Legislative Council approves the FY 2020
31 Department of Public Safety U.S. Department of Justice SORNA Program Budget
32 in the amount of \$160,354.98 effective October 1, 2019, which shall be funded by



1 the Nation's general fund pending reimbursement from the grantor, the U.S.
2 Department of Justice, Office of Justice Programs.


3 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
4 Nation chairperson or any designated official is authorized to administer and
5 expend the FY 2020 Department of Public Safety U.S. Department of Justice SORNA
6 Program Budget, provided that any amendments or modifications shall be
7 submitted for prior approval by the Tohono O'odham Legislative Council.

8 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH
9 day of FEBRUARY, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;
10 -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
11 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by
12 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
13 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
14 18, 1934 (48 Stat.984).


