

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Sells District Budgets)**

RESOLUTION NO. 20-060

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** by Resolution No. 18-242, the Legislative Council authorized the distribution of
13 ASARCO mining royalties held at the United States Department of the Interior,
14 Office of the Special Trustee making available district allocations subject to
15 budgets approved in accordance with Article VI, Section 1(d)(2) and Article IX,
16 Section 7 of the Nation's Constitution; and

17 **WHEREAS,** by Sells District Council Resolutions No. 11-20, No. 125-19, No. SD-123-19, No. SD-
18 23-20, No. SD-24-20 and No. SD-06-20 the Sells District has authorized and
19 submitted for review and approval the following Sells District Budgets, which are
20 incorporated herein by reference:

- 21 1. FY2020 Sells District Cowlic Community INT-01-14 Budget in the amount
22 of \$12,550.39;
- 23 2. FY2020 Sells District North Communities Mining Royalties Budget in the
24 amount of \$13,985.65;
- 25 3. FY2020 Sells District North Communities ASARCO Mining Budget in the
26 amount of \$69,620.27;
- 27 4. FY2020 Sells District Ge Oidag Community ASARCO Mining Budget in the
28 amount of \$93,030.27;
- 29 5. FY2020 Sells District Ge Oidag Community INT-01-14 Budget in the amount
30 of \$6,615.00;
- 31 6. FY2020 Sells District Administration ASARCO Mining Budget in the amount
32 of \$87,366.28; and

33 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2020 Sells District
34 Budgets listed above and recommends their approval.

1 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
2 following FY 2020 Sells District Budgets:

- 3 1. FY2020 Sells District Cowlic Community INT-01-14 Budget in the amount
4 of \$12,550.39;
- 5 2. FY2020 Sells District North Communities Mining Royalties Budget in the
6 amount of \$13,985.65;
- 7 3. FY2020 Sells District North Communities ASARCO Mining Budget in the
8 amount of \$69,620.27;
- 9 4. FY2020 Sells District Ge Oidag Community ASARCO Mining Budget in the
10 amount of \$93,030.27;
- 11 5. FY2020 Sells District Ge Oidag Community INT-01-14 Budget in the amount
12 of \$6,615.00; and
- 13 6. FY2020 Sells District Administration ASARCO Mining Budget in the amount
14 of \$87,366.28.

15 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2020 Sells
16 District Budgets identified above shall be managed and expended in accordance
17 with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and
18 the Nation's laws, provided that any amendments or modifications shall be
19 authorized under District Council resolution and submitted for prior approval by
20 the Tohono O'odham Legislative Council.


21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH
22 day of FEBRUARY, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;
23 -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
24 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
25 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
26 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
27 (48 Stat.984).


