RESOLUTION NO. 20-065

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Article II,**
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
6 **Enrollment Committee is responsible for reviewing enrollment applications and**
7 **making recommendations to the Legislative Council regarding the eligibility of**
8 **applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

9 **WHEREAS, Article VIII of the Nation's Enrollment Ordinance provides that the Tohono**
10 **O'odham Legislative Council shall determine whether an application is approved**
11 **for membership and its determination, along with the resolution number and**
12 **date of enactment, shall be provided to the applicant; and**

13 **WHEREAS, the Enrollment Program has received the official documents showing the legal**
14 **name changes of enrolled members due to a variety of reasons, such as marriage,**
15 **divorce, or legal adoption; and**

16 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 37-80, 83-**
17 **83, 127-83, 131-84, 92-247, 93-277, 94-348, 95-051, 96-129, 97-036, 98-034, 98-083,**
18 **98-123, 02-042, 02-074, 02-241, 13-109, 14-081, 14-254, 14-319, 17-169, 17-579 and**
19 **18-220 be amended to reflect the amended names for the members identified in**
20 **the March 2020 Amended Enrollment Resolution Summary, which is**
21 **incorporated by this reference.**

22 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
23 **Nos. 37-80, 83-83, 127-83, 131-84, 92-247, 93-277, 94-348, 95-051, 96-129, 97-036,**
24 **98-034, 98-083, 98-123, 02-042, 02-074, 02-241, 13-109, 14-081, 14-254, 14-319, 17-**
25 **169, 17-579 and 18-220 are amended upon the effective date of those resolutions**
26 **to reflect the legal name changes for the members identified in the March 2020**
27 **Amended Enrollment Resolution Summary.**

29 **day of MARCH, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**

31 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**

33 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
34 **16 of the Act of June 18, 1934 (48 Stat.984).**
