

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Chukut Kuk District Budget Amendment No. 3)

RESOLUTION NO. 20-071

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2020 Chukut Kuk District Budget in the amount of \$2,129,448.90 was
13 authorized by Chukut Kuk District Council Resolution No. 2019-39 and approved
14 by Legislative Council Resolution No. 19-352, and subsequently amended by
15 Chukut Kuk Resolution No. 2019-45 and approved by Legislative Council
16 Resolution No. 19-461 in the amount of \$2,405,912.32, and subsequently amended
17 by Chukut Kuk Resolution No. 2019-51 and approved by Legislative Council
18 Resolution No. 20-024 in the amount of \$2,433,768.02; and

19 **WHEREAS,** by Chukut Kuk District Council Resolution No. 2019-55, the Chukut Kuk District
20 Council has authorized and submitted for review and approval its FY 2020 Chukut
21 Kuk District Budget Amendment No. 3, which is incorporated by this reference
22 and which will adjust operational and/or personnel line items; and

23 **WHEREAS,** the FY 2020 Chukut Kuk District Budget Amendment No. 3 will not change the
24 budget amount of \$2,433,768.02; and

25 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2020 Chukut Kuk District
26 Budget Amendment No. 3 and recommends its approval.

27 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
28 FY 2020 Chukut Kuk District Budget Amendment No. 3, which will not change the
29 budget amount of \$2,433,768.02.

30 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2020 Chukut
31 Kuk District Budget as amended shall be managed and expended in accordance
32 with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and
33 the Nation's laws, provided that any amendments or modifications shall be
34 authorized under District Council resolution and submitted for prior approval by
35 the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02ND day of MARCH, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article IX, Sections 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


