

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Setting March 25, 2020 Special Session for a Tohono O'odham Farming
Authority Update at San Lucy Farms)

LEGISLATIVE ORDER NO. 20-072

1 **WHEREAS,** the Legislative Council is vested with the power "to establish rules and
2 procedures to regulate all meetings of the Tohono O'odham Council, standing
3 committees, boards and special committees." (Constitution of the Tohono
4 O'odham Nation, Article VI, Section 1(a)); and

5 **WHEREAS,** the Legislative Rules of the Tohono O'odham Legislative Council vests the Council
6 with the authority to "by majority vote, call for a special session" (Legislative
7 Rules of the Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and


8 **WHEREAS,** Article I, Section 2(C) of the Legislative Rules of the Tohono O'odham Legislative
9 Council, provides that "[a]ll Legislative Council sessions shall be held at the
10 Tohono O'odham Legislative Council chambers located in Sells, Tohono O'odham
11 Nation, with the following exceptions. . . [a] majority of all the legislative
12 representatives may vote to hold a session in some location other than the
13 chambers located at Sells."; and

14 **WHEREAS,** the Agricultural and Natural Resources Committee has requested a special
15 session on March 25, 2020 for a Tohono O'odham Farming Authority ("TOFA")
16 update by the TOFA Interim Board at San Lucy Farms.

17 **NOW, THEREFORE, BE IT ORDERED** by the Tohono O'odham Legislative Council that it sets a
18 special session on March 25, 2020 for a Tohono O'odham Farming Authority
19 update by the TOFA Interim Board at San Lucy Farms.


20 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 02ND day of
21 MARCH, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;
22 -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
23 Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the
24 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
25 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
26 18, 1934 (48 Stat.984).
