

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Veterans Affairs Office Donations and Contributions
Budget Amendment No. 1)

RESOLUTION NO. 20-073

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2020 Veterans Affairs Office Donations and Contributions Budget in the**
8 **amount of \$56,716.44 was approved by Resolution No. 19-415; and**

9 **WHEREAS, the Veterans Affairs Office has prepared and submitted for review and approval**
10 **its FY 2020 Veterans Affairs Office Donations and Contributions Budget**
11 **Amendment No. 1, which is incorporated by this reference and which will adjust**
12 **operational and/or personnel line items; and**

13 **WHEREAS, the FY 2020 Veterans Affairs Office Donations and Contributions Budget**
14 **Amendment No. 1 will increase the FY 2020 Veterans Affairs Office Donations and**
15 **Contributions Budget by \$4,999.99 from \$56,716.44 to \$61,716.43; and**

16 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
17 **reviewed the FY 2020 Veterans Affairs Office Donations and Contributions Budget**
18 **Amendment No. 1 and recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2020 Veterans Affairs Office Donations and Contributions Budget Amendment**
21 **No. 1, which includes a \$4,999.99 increase from \$56,716.44 to \$61,716.43 that shall**
22 **be funded by revenue donations.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2020 Veterans Affairs Office Donations and Contributions Budget**
26 **as amended, provided that any amendments or modifications shall be submitted**
27 **for prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD**
29 **day of MARCH, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
30 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**




