

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Hewel Ni'ok Administration Budget Amendment No. 1)**

RESOLUTION NO. 20-074

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2020 Hewel Ni'ok Administration Budget in the amount of \$556,920.33 was
8 approved by Resolution No. 19-323; and

9 **WHEREAS,** Hewel Ni'ok has prepared and submitted for review and approval its FY 2020
10 Hewel Ni'ok Administration Budget Amendment No. 1, which is incorporated by
11 this reference and which will adjust operational and/or personnel line items; and

12 **WHEREAS,** the FY 2020 Hewel Ni'ok Administration Budget Amendment No. 1 increases the
13 original budget amount of \$556,920.33 by \$31,495.41 to \$588,415.74; and

14 **WHEREAS,** the FY 2020 Hewel Ni'ok Administration Budget Amendment No. 1 funds a
15 Programming Assistant position and related employee benefits; and

16 **WHEREAS,** the Cultural Preservation and Budget and Finance Committees have reviewed the
17 FY 2020 Hewel Ni'ok Administration Budget Amendment No. 1 and recommend its
18 approval.


19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
20 FY 2020 Hewel Ni'ok Administration Budget Amendment No. 1 effective October 1,
21 2019, in the amount of \$588,415.74 which increases the original amount of
22 \$556,920.33 by \$31,495.41 and funds a Programming Assistant position and
23 related employee benefits.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
25 Nation chairperson or any designated official is authorized to administer and
26 expend the FY 2020 Hewel Ni'ok Administration Budget as amended, provided
27 that any amendments or modifications shall be submitted for prior approval by
28 the Tohono O'odham Legislative Council.


29 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD
30 day of MARCH, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;
31 -0- AGAINST; [01] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
32 Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the
33 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
34 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
35 18, 1934 (48 Stat.984).




