

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Office of the Chairman Tribal Gaming Public Outreach
Campaign Budget)

RESOLUTION NO. 20-085

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Office of the Chairman has prepared and submitted for review and approval
8 its FY 2020 Tribal Gaming Public Outreach Campaign Budget, which is
9 incorporated by this reference, in the amount of \$173,303.00, which shall be
10 funded by the Nation's general fund; and

11 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2020 Office of the
12 Chairman Tribal Gaming Public Outreach Campaign Budget and recommends its
13 approval.

14 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
15 FY 2020 Office of the Chairman Tribal Gaming Public Outreach Campaign Budget,
16 effective October 1, 2019, in the amount of \$173,303.00, which shall be funded by
17 the Nation's general fund.

18 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
19 Nation chairperson or any designated official is authorized to administer and
20 expend the FY 2020 Office of the Chairman Tribal Gaming Public Outreach
21 Campaign Budget, provided that any amendments or modifications shall be
22 submitted for prior approval by the Tohono O'odham Legislative Council.

23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH
24 day of MARCH, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;
25 -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
26 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by
27 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
28 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
29 18, 1934 (48 Stat.984).
