

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appropriating Funds for International Sonoran Desert Alliance 2020 Tri-National
Sonoran Desert Symposium)

RESOLUTION NO. 20-086

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power "to promote
2 efforts which will preserve and protect the natural and cultural environment of
3 the Nation" (Constitution of the Tohono O'odham Nation, Article XVIII, Section 1);
4 and

5 **WHEREAS,** the Tohono O'odham Legislative Council is also authorized "to manage any funds
6 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
7 these funds for the benefit of the nation and its members" provided that "[a]ll
8 expenditures of these funds shall be pursuant to appropriations or budgets"
9 authorized by resolution or ordinance (Constitution of the Tohono O'odham
10 Nation, Article VI, Section 1(d)(2)); and

11 **WHEREAS,** the International Sonoran Desert Alliance ("ISDA") founded in 1993, is a non-
12 profit corporation whose mission is to design and implement environmental,
13 cultural, real estate and business development projects intended to preserve and
14 enrich the environment, culture, and economy of the Sonoran Desert; and

15 **WHEREAS,** the ISDA 2020 Tri-National Sonoran Desert Symposium will be held March 9-12,
16 2020 in Ajo, Arizona and will focus on "cultural and natural resource issues,
17 Native American tribal perspectives in the Sonoran Desert, and Sonoran Desert
18 Foodways"; and

19 **WHEREAS,** the Cultural Preservation Committee recommends that the Nation appropriate
20 \$3,000.00 for sponsorship of the ISDA 2020 Tri-National Sonoran Desert
21 Symposium and to assist Nation's members; and


22 **WHEREAS,** the Budget and Finance Committee has reviewed the funding request to ISDA and
23 recommends approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council appropriates
25 \$3,000.00 from the Nation's general fund to ISDA for the 2020 Tri-National
26 Sonoran Desert Symposium.

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH**
28 **day of MARCH, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
29 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(2) and XVIII, Section 1 of the Constitution of the Tohono O'odham Nation,**
31 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
32 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
33 **Act of June 18, 1934 (48 Stat.984).**




