

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting Legislative Branch COVID-19 Pandemic Response Plan and
Delegating Authority to Legislative Council Officers)

LEGISLATIVE ORDER NO. 20-095

1 **WHEREAS,** the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2 the authority to "establish rules and procedures to regulate all meeting of the
3 Tohono O'odham Council, standing committees, boards and special committees"
4 and to "promote, protect and provide for public health, peace, morals, education
5 and general welfare of the Tohono O'odham Nation and its members. . ."
6 (Constitution, Article VI, Section 1(a) and Section 1(c)(2)); and

7 **WHEREAS,** the recent outbreak of the novel coronavirus identified as COVID-19 in the United
8 States, including the State of Arizona, causes deep concern for the health and
9 safety of the Tohono O'odham Nation (the "Nation") and its members, and the
10 preservation of the Nation's culture and economic stability; and


11 **WHEREAS,** the Governor of the State of Arizona declared a Public Health Emergency on
12 March 11, 2020, in order to release federal resources to prepare, mitigate, and
13 respond to the needs of tribal and local jurisdictions; and

14 **WHEREAS,** the Rules Committee, in consultation with the Legislative Council officers,
15 reviewed and recommended approval of the Legislative Branch COVID-19
16 Pandemic Response Plan, which is incorporated by this reference.

17 **NOW, THEREFORE, BE IT ORDERED** that the Tohono O'odham Legislative Council adopts the
18 Legislative Branch COVID-19 Pandemic Response Plan and delegates authority to
19 the Legislative Council chairperson and vice chairperson to implement the Plan.

20 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 16TH day of
21 MARCH, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;
22 -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
23 Article VI, Section 1(a) and Section 1(c)(2) of the Constitution of the Tohono O'odham Nation,
24 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
25 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
26 Act of June 18, 1934 (48 Stat.984).
