

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Gu Achi District COVID-19 Pandemic Budget and FY 2020
Gu Achi District COVID-19 Pandemic for Quarantined Households Budget)**

RESOLUTION NO. 20-097

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** by Gu Achi District Council Resolutions No. 0320-089 and No. 0320-090 the Gu Achi
13 District has authorized the FY 2020 Gu Achi District COVID-19 Pandemic Budget
14 in the amount of \$109,348.00 and the FY 2020 Gu Achi District COVID-19 Pandemic
15 for Quarantined Households Budget in the amount of \$60,000.00, which are
16 incorporated by these references and which shall be funded by the Gu Achi
17 District Savings Account; and

18 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2020 Gu Achi District
19 COVID-19 Pandemic Budget and the FY 2020 Gu Achi District FY 2020 COVID-19
20 Pandemic for Quarantined Households Budget and recommends their approval.

21 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that it
22 approves:

- 23 (1) FY 2020 Gu Achi District COVID-19 Pandemic Budget in the amount of
24 \$109,348.00 which shall be funded by the Gu Achi District Savings Account;
25 and
26 (2) FY 2020 Gu Achi District COVID-19 Pandemic for Quarantined Households
27 Budget in the amount of \$60,000.00 which shall be funded by the Gu Achi
28 District Savings Account.

29 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2020 Gu Achi
30 District COVID-19 Pandemic Budget and the FY 2020 Gu Achi District COVID-19
31 Pandemic for Quarantined Households Budget shall be managed and expended
32 in accordance with Article IX, Section 7 of the Constitution of the Tohono
33 O'odham Nation and the Nation's laws, provided that any amendments or






