

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2020 Sif-Oidak District Gaming Revenue Remaining Allocation  
Community Budget)**

**RESOLUTION NO. 20-100**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only by  
6 a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

12 **WHEREAS,** by Sif-Oidak District Council Resolution No. SODC 20-025, the Sif-Oidak District  
13 has authorized and submitted for review and approval the FY 2020 Sif-Oidak  
14 District Gaming Revenue Remaining Allocation Community Budget, which is  
15 incorporated by this reference, in the amount of \$345,002.46; and

16 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2020 Sif-Oidak District  
17 Gaming Revenue Remaining Allocation Community Budget and recommends  
18 approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
20 FY 2020 Sif-Oidak District Gaming Revenue Remaining Allocation Community  
21 Budget in the amount of \$345,002.46.

22 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2020 Sif-Oidak  
23 District Gaming Revenue Remaining Allocation Community Budget shall be  
24 managed and expended in accordance with Article IX, Section 7 of the  
25 Constitution of the Tohono O'odham Nation and the Nation's laws, provided that  
26 any amendments or modifications shall be authorized under District Council  
27 resolution and submitted for prior approval by the Tohono O'odham Legislative  
28 Council.

29 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25<sup>TH</sup>  
30 day of MARCH, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;  
31 -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by  
32 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
33 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
34 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934  
35 (48 Stat.984).
