

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution Nos. 09-85, 58-85, 704-85, 95-082, 97-256,
08-100, 18-033, and 19-388 to Reflect Legal Name Changes of Enrolled Members)**

RESOLUTION NO. 20-104

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Article II,**
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
6 **Enrollment Committee is responsible for reviewing enrollment applications and**
7 **making recommendations to the Legislative Council regarding the eligibility of**
8 **applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

9 **WHEREAS, Article VIII of the Nation's Enrollment Ordinance provides that the Tohono**
10 **O'odham Legislative Council shall determine whether an application is approved**
11 **for membership and its determination, along with the resolution number and**
12 **date of enactment, shall be provided to the applicant; and**


13 **WHEREAS, the Enrollment Program has received the official documents showing the legal**
14 **name changes of enrolled members due to a variety of reasons, such as marriage,**
15 **divorce, or legal adoption; and**

16 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 09-85, 58-**
17 **85, 704-85, 95-082, 97-256, 08-100, 18-033, and 19-388 be amended to reflect the**
18 **amended names for the members identified in the April 2020 Amended**
19 **Enrollment Resolution Summary, which is incorporated by this reference.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
21 **Nos. 09-85, 58-85, 704-85, 95-082, 97-256, 08-100, 18-033, and 19-388 are amended**
22 **upon the effective date of those resolutions to reflect the legal name changes for**
23 **the members identified in the April 2020 Amended Enrollment Resolution**
24 **Summary.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH**
26 **day of APRIL, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
27 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
28 **Article II, Section 1 and Section 2 and Article VI, Section 1(h) of the Constitution of the Tohono**
29 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; approved by the**
30 **Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
31 **Section 16 of the Act of June 18, 1934 (48 Stat.984).**
