

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 19-447, "Amending Enrollment Resolutions Nos. 66-80,
138-81, 86-82, 150-82, 83-83, 127-83, 67-84, 94-262, 94-459, 94-504, 99-475, 04-109,
05-301, 07-007, 08-100, 17-043, 18-146, 18-220, and 18-425 to Reflect Legal Name
Changes of Enrollment Members" to Remove References to Resolution No. 95-051)**

RESOLUTION NO. 20-106

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws
2 and ordinances governing the enrollment and adoption of members
3 (Constitution of the Tohono O'odham Nation, Article VI, Section 1(h)); and

4 **WHEREAS,** Articles VI and VII of the Nation's Enrollment Ordinance provide that the
5 Enrollment Committee is responsible for reviewing enrollment applications and
6 making recommendations to the Legislative Council regarding the eligibility of
7 applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and

8 **WHEREAS,** Article VIII of the Nation's Enrollment Ordinance provides that the Tohono
9 O'odham Legislative Council shall determine whether an application is approved
10 for membership and its determination, along with the resolution number and
11 date of enactment, shall be provided to the applicant; and

12 **WHEREAS,** it is necessary to amend Resolution No. 19-447 to remove erroneous references to
13 Resolution No. 95-051 in the final whereas clause and resolved clause of
14 Resolution No. 19-447.

15 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution
16 Nos. 19-447 is amended upon the effective date of that resolution to remove
17 references to Resolution No. 95-051 in the final whereas clause and resolved
18 clause, as follows:

20 **WHEREAS,** the Enrollment Program therefore recommends that Resolution
21 Nos. 66-80, 138-81, 86-82, 150-82, 83-83, 127-83, 67-84, 94-262, 94-459, 94-504, 99-
22 475, 04-109, 05-301, 07-007, 08-100, 17-043, 18-146, 18-220, and 18-425 be amended
23 to reflect the amended names for the members identified in the December 2019
24 Amended Enrollment Resolution Summary, which is incorporated by this
25 reference.
