

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution No. 76-83 "Making Additions to Official Census
Roll", Resolution No. 84-83 "Base Roll Additions," and Resolution No. 91-90
"Base Roll Addition")

RESOLUTION NO. 20-107

1 **WHEREAS, Article II, Section 1 of the Constitution of the Tohono O'odham Nation provides in**
2 **part that the membership of the Tohono O'odham Nation consists of the**
3 **following:**

4 **(a) All Indians whose names appear on the official census rolls of the Sells and**
5 **Gila Bend Reservations as of January 1, 1937, and of the San Xavier**
6 **Reservation as of January 1, 1940, provided that additions and changes**
7 **may be made to said rolls by the Tohono O'odham Council, subject to the**
8 **approval of the Secretary of the Interior.**

9 **(Constitution, Article II, Section 1(a)); and**

10 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
11 **and ordinances governing the enrollment and adoption of members**
12 **(Constitution of the Tohono O'odham Nation, Article VI, Section 1(h)); and**

13 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
14 **Enrollment Committee is responsible for reviewing enrollment applications and**
15 **making recommendations to the Legislative Council regarding the eligibility of**
16 **applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

17 **WHEREAS, Article I, Section 2 of the Enrollment Ordinance provides that the "base roll' is**
18 **created by the Nation from the official census rolls of the Sells and Gila Bend**
19 **Reservations as of January 1, 1937, and of the San Xavier Reservation as of January**
20 **1, 1940; provided that additions and changes may be made to said rolls by the**
21 **Tohono O'odham Council, subject to the approval of the Secretary of the Interior**
22 **solely to the extent such approval is expressly required by the Nation's**
23 **Constitution"; and**

24 **WHEREAS, the Enrollment Program has determined that certain members were incorrectly**
25 **approved for membership as base roll additions by Resolution No. 76-83,**
26 **Resolution No.84-83 and Resolution No. 91-90, because they were already listed**
27 **on the 1937 census roll, and therefore already on the Nation's base roll; and**

28 **WHEREAS, the Enrollment Program recommends that the resolutions in the attached**
29 **"Amending Enrollment Resolution List April 2020" ("Members") be amended to**
30 **correct the Members' status as part of the Nation's base roll and not base roll**

1 **WHEREAS, the Members shall retain their census roll number, enrollment roll number, and**
2 **data they received enrollment number as indicated in the attached "Amending**
3 **Enrollment Resolution List April 2020."**

4 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
5 **No. 76-83 "Making Additions to Official Census Rolls", Resolution No. 84-83 "Base**
6 **Roll Additions" and Resolution No. 91-90 "Base Roll Addition" are amended to**
7 **remove the indicated Members as base roll additions, because the Members are**
8 **already on the Nation's base roll, provided that the Members shall retain their**
9 **census roll number and enrollment roll number as indicated in the attached**
10 **"Amending Enrollment Resolution List April 2020".**

11 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH**
12 **day of APRIL, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
13 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
14 **Article II, Section 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**
15 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; approved by the Acting**
16 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
17 **16 of the Act of June 18, 1934 (48 Stat.984).**


