

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 San Xavier District Budget Amendment No. 2)**

RESOLUTION NO. 20-112

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2020 San Xavier District Budget in the amount of \$10,281,911.53 was
13 authorized by San Xavier District Council Resolution No. SXDC 08-19-12 and
14 approved by Legislative Council Resolution No. 19-356, and subsequently
15 amended by Legislative Council Resolution No. 20-078 in the amount of
16 \$10,356,911.53; and

17 **WHEREAS,** the San Xavier District applied for and received grant funds from (1) the Vance
18 Foundation in the amount of \$25,000.00 to fund a first-ever District community
19 park and (2) the USDA Natural Resources Conservation Services (the "NRCS") in
20 the amount of \$500,000.00 to fund the District Cemetery Wash Project; and

21 **WHEREAS,** by San Xavier District Council Resolution No. SXDC 03-20-02, the San Xavier
22 District has authorized and submitted for review and approval its FY 2020 San
23 Xavier District Budget Amendment No. 2, which is incorporated by this reference;
24 and

25 **WHEREAS,** the FY 2020 San Xavier District Budget Amendment No. 2 will increase the FY 2020
26 San Xavier District Budget by \$525,000.00 from \$10,356,911.53 to \$10,881,911.53
27 by incorporating the Vance Foundation and USDA NRCS grant funds; and

28 **WHEREAS,** the Agricultural and Natural Resources, Water Resources, and Budget and
29 Finance Committees have reviewed the FY 2020 San Xavier District Budget
30 Amendment No. 2 and recommend approval.

31 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
32 FY 2020 San Xavier District Budget Amendment No. 2, which includes a
33 \$525,000.00 increase from \$10,356,911.53 to \$10,881,911.53 that shall be funded
34 by the Vance Foundation and USDA NRCS grant funds.

1 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2020 San
2 Xavier District Budget, as amended shall be managed and expended in
3 accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham
4 Nation and the Nation's laws, provided that any amendments or modifications
5 shall be authorized under a District Council resolution and submitted for prior
6 approval by the Tohono O'odham Legislative Council.

7 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH
8 day of APRIL, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;
9 -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
10 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
11 O'odham Nation on January 18, 1986; approved by the Acting Deputy Assistant Secretary - Indian
12 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
13 Stat.984).
