

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Chukut Kuk District Tecolote Community Budget Amendment
No. 1 and FY 2020 Chukut Kuk District Budget Amendment No. 4)

RESOLUTION NO. 20-114

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2020 Chukut Kuk District Budget in the amount of \$2,129,448.90 was
13 authorized by Chukut Kuk District Council Resolution No. 2019-39 and approved
14 by Legislative Council Resolution No. 19-352, and subsequently amended by
15 Legislative Council Resolution No. 19-461 in the amount of \$2,405,912.32 and
16 further amended by Legislative Council Resolution No. 20-024 in the amount of
17 \$2,433,768.02 and Resolution No. 20-071 in the amount of \$2,433,768.02; and

18 **WHEREAS,** by Chukut Kuk District Council Resolution No. 2020-08 and Resolution No. 2020-
19 11, the Chukut Kuk District has authorized and submitted for review and
20 approval its FY 2020 Tecolote Community Budget Amendment No. 1 and FY 2020
21 Chukut Kuk District Budget Amendment No. 4, which are incorporated by these
22 references and which will adjust operational and/or personnel line items; and

23 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2020 Chukut Kuk District
24 Tecolote Community Budget Amendment No. 1 and the FY 2020 Chukut Kuk
25 District Budget Amendment No. 4 and recommend their approval.

26 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves:

- 27 (1) FY 2020 Chukut Kuk District Tecolote Community Budget Amendment No.
28 1, which includes a \$86,359.60 increase from \$40,000.00 to \$126,359.60 that
29 shall be funded by FY 2016 Mining Royalties and FY 2019 Surplus Funds;
30 and
31 (2) FY 2020 Chukut Kuk District Budget Amendment No. 4, which includes a
32 \$160,000.00 increase that shall be funded by the remaining FY 2020
33 Chukut Kuk District gaming allocation and incorporates the FY 2020
34 Tecolote Community Budget Amendment No. 1.



2 **\$246,359.60 from \$2,433,768.02 to \$2,680,127.62.**


3 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2020 Chukut
4 **Kuk District Budget as amended shall be managed and expended in accordance**
5 **with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and**
6 **the Nation's laws, provided that any amendments or modifications shall be**
7 **authorized under District Council resolution and submitted for prior approval by**
8 **the Tohono O'odham Legislative Council.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH**
10 **day of APRIL, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
11 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
12 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
13 **O'odham Nation on January 18, 1986; approved by the Acting Deputy Assistant Secretary - Indian**
14 **Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
15 **Stat.984).**


