

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Requesting CARES Act Funding Be Disbursed to the Social Services/Family
Assistance Line Item of the Nation's Current ISDEAA Agreement)**

RESOLUTION NO. 20-123

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power "to consult, negotiate and conclude agreements and contracts on**
3 **behalf of the Tohono O'odham Nation with Federal, State and local governments**
4 **and other Indian tribes or their departments, agencies, or political subdivisions,**
5 **or with private persons or organizations on all matters within the authority of the**
6 **Tohono O'odham Council." (Constitution, Article VI, Section 1(f)); and**

7 **WHEREAS, pursuant to Title I of the Indian Self-Determination and Education Assistance Act**
8 **(ISDEAA), as amended (25 U.S.C. Ch. 46) the Tohono O'odham Nation entered into**
9 **an Agreement with the Secretary of the Department of the Interior which**
10 **commenced with the 2006 Fiscal Year; and**

11 **WHEREAS, on March 27, 2020 the President of the United States signed the Coronavirus Aid,**
12 **Relief, and Economic Security Act (CARES Act), P.L. 116-136 into law; and**

13 **WHEREAS, the CARES Act authorizes \$522 million in direct appropriations to for COVID-19**
14 **response activities; and**

15 **WHEREAS, a portion of the funding under the CARES Act is to be distributed though Aid to**
16 **Tribal Governments and the Welfare Assistance Grant line item of a current**
17 **ISDEAA Agreement; and**

18 **WHEREAS, the Nation's current ISDEAA Agreement does not contain either an Aid to Tribal**
19 **Government or a Welfare Assistance Grant line item; and**

20 **WHEREAS, the Bureau of Indian Affairs - Regional Awarding Official is requiring a Tohono**
21 **O'odham Legislative Council resolution requesting that the CARES Act funds**
22 **allotted to the Nation be disbursed to the Social Services/Family Assistance line**
23 **item in the Nation's current ISDEAA Agreement; and**

24 **WHEREAS, the Budget and Finance Committee has reviewed this resolution and**
25 **recommends its approval.**

26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council requests the**
27 **CARES Act Funding allotted to the Nation be disbursed to the Social**
28 **Services/Family Assistance line item in the Nation's current ISDEAA Agreement.**

29 **BE IT FURTHER RESOLVED the funds distributed pursuant to this resolution shall not be spent**
30 **except through a budget approved by the Tohono O'odham Legislative Council.**

31 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the funds received**
32 **from the CARES Act Grant will be used solely for COVID-19 response activities.**




