

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2020 Department of Health and Human Services Family Violence  
Prevention Budget Amendment No. 1)**

**RESOLUTION NO. 20-125**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2020 Department of Health and Human Services Family Violence**  
8 **Prevention Budget in the amount of \$208,373.12 was approved by Resolution No.**  
9 **19-332; and**

10 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**  
11 **review and approval its FY 2020 Family Violence Prevention Budget Amendment**  
12 **No. 1, which is incorporated by this reference and which will adjust personnel**  
13 **and/or operational line items; and**

14 **WHEREAS, the FY 2020 Department of Health and Human Services Family Violence**  
15 **Prevention Budget Amendment No. 1 will increase the FY 2020 Department of**  
16 **Health and Human Services Family Violence Prevention Budget by \$918.88 from**  
17 **\$208,373.12 to \$209,292.00; and**

18 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
19 **reviewed the FY 2020 Department of Health and Human Services Family Violence**  
20 **Prevention Budget Amendment No. 1 and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
22 **FY 2020 Department of Health and Human Services Family Violence Prevention**  
23 **Budget Amendment No. 1, effective October 1, 2019 which includes a \$918.88**  
24 **increase from \$208,373.12 to \$209,292.00 that shall be funded by the Nation's**  
25 **general fund pending reimbursement from the grantor, the Department of**  
26 **Health and Human Services Administration for Children and Families.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
28 **Nation chairperson or any designated official is authorized to administer and**  
29 **expend the FY 2020 Department of Health and Human Services Family Violence**  
30 **Prevention Budget as amended, provided that any amendments or modifications**  
31 **shall be submitted for prior approval by the Tohono O'odham Legislative Council.**
