

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Department of Health and Human Services Division of
Child Welfare Title IV-B Subparts 1 and 2 Carry Forward Budgets)**

RESOLUTION NO. 20-126

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
8 **review and approval its FY 2020 Division of Child Welfare Title IV-B Subpart 1**
9 **Carry Forward Budget in the amount of \$52,328.74 that shall be funded by the**
10 **Stephanie Tubbs Jones Child Welfare Services Program and Title IV-B Subpart 2**
11 **Carry Forward Budget in the amount of \$40,750.16 that shall be funded by the**
12 **Promoting Safe and Stable Families, and which are incorporated by these**
13 **references; and**

14 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
15 **reviewed the FY 2020 Department of Health and Human Services Division of Child**
16 **Welfare Title IV-B Subparts 1 and 2 Carry Forward Budgets and recommend their**
17 **approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2020 Department of Health and Human Services Division of Child Welfare Title**
20 **IV-B Subpart 1 Carry Forward Budget in the amount of \$52,328.74, which shall be**
21 **funded by the Stephanie Tubbs Jones Child Welfare Services Program and Title**
22 **IV-B Subpart 2 Carry Forward Budget in the amount of \$40,750.16, which shall be**
23 **funded by the Promoting Safe and Stable Families, effective October 1, 2019.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
25 **Nation chairperson or any designated official is authorized to administer and**
26 **expend the FY 2020 Department of Health and Human Services Division of Child**
27 **Welfare Title IV-B Subparts 1 and 2 Carry Forward Budgets, provided that any**
28 **amendments or modifications shall be submitted for prior approval by the**
29 **Tohono O'odham Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29TH**
31 **day of APRIL, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
32 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
33 **Article IV, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
34 **the Tohono O'odham Nation on January 18, 1986; approved by the Acting Deputy Assistant**
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
36 **18, 1934 (48 Stat.984).**
