

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2020 Department of Health and Human Services Division of  
Community Health Services Public Health Emergency Preparedness FY 2018  
And FY 2019 Carry Forward Budgets)**

**RESOLUTION NO. 20-129**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for  
8 review and approval its FY 2020 Division of Community Health Services Public  
9 Health Emergency Preparedness ("PHEP") FY 2018 Carry Forward Budget in the  
10 amount of \$11,691.82 and its FY 2019 Carry Forward Budget in the amount of  
11 \$4,932.17, which are incorporated by these references, to be funded by FY 2018  
12 and FY 2019 carry forward funds from the Arizona Department of Health Services;  
13 and

14 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
15 reviewed the FY 2020 Department of Health and Human Services Division of  
16 Community Health Services Public Health Emergency Preparedness FY 2018 and  
17 FY 2019 Carry Forward Budgets and recommend their approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves:

- 19 (1) **FY 2020 Department of Health and Human Services Division of Community**  
20 **Health Services PHEP FY 2018 Carry Forward Budget effective July 1, 2019**  
21 **in the amount of \$11,691.82, which shall be funded by FY 2018 PHEP carry**  
22 **forward funds from the Arizona Department of Health Services; and**
- 23 (2) **FY 2020 Department of Health and Human Services Division of Community**  
24 **Health Services PHEP FY 2019 Carry Forward Budget effective July 1, 2019**  
25 **in the amount of \$4,932.17 which shall be funded by FY 2019 PHEP carry**  
26 **forward funds from the Arizona Department of Health Services.**

27 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
28 Nation chairperson or any designated official is authorized to administer and  
29 expend the FY 2020 Department of Health and Human Services Division of  
30 Community Health Services Public Health Emergency Preparedness FY 2018 and  
31 FY 2019 Carry Forward Budgets, provided that any amendments or modifications  
32 shall be submitted for prior approval by the Tohono O'odham Legislative Council.
