

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Department of Public Safety 638 Corrections Program
Budget Amendment No. 1)**

RESOLUTION NO. 20-136

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2020 Department of Public Safety 638 Corrections Program Budget in the**
8 **amount of \$4,539,744.05 was approved by Resolution No. 19-300; and**

9 **WHEREAS, the Department of Public Safety has prepared and submitted for review and**
10 **approval its FY 2020 638 Corrections Program Budget Amendment No. 1, which is**
11 **incorporated by this reference, and which will adjust operational and/or**
12 **personnel line items; and**

13 **WHEREAS, the FY 2020 Department of Public Safety 638 Corrections Program Budget**
14 **Amendment No. 1 will increase the FY 2020 Department of Public Safety 638**
15 **Corrections Program Budget by \$1,089,730.30 from \$4,539,744.05 to**
16 **\$5,629,474.35; and**

17 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**
18 **2020 Department of Public Safety 638 Corrections Program Budget Amendment**
19 **No. 1 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2020 Department of Public Safety 638 Corrections Program Budget**
22 **Amendment No. 1 effective October 1, 2019, which includes a \$1,089,730.30**
23 **increase from \$4,539,744.05 to \$5,629,474.35 that shall be funded by carryover**
24 **savings.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
26 **Nation chairperson or any designated official is authorized to administer and**
27 **expend the FY 2020 Department of Public Safety 638 Corrections Program Budget**
28 **as amended, provided that any amendments or modifications shall be submitted**
29 **for prior approval by the Tohono O'odham Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29TH**
31 **day of APRIL, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
32 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
33 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
34 **the Tohono O'odham Nation on January 18, 1986; approved by the Acting Deputy Assistant**
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
36 **18, 1934 (48 Stat.984).**


