

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Department of Public Safety Office of Emergency
Management Budget Amendment No. 1)

RESOLUTION NO. 20-137

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2020 Department of Public Safety Office of Emergency Management Budget
8 in the amount of \$990,782.89 was approved by Resolution No. 19-323; and

9 **WHEREAS,** the Department of Public Safety has prepared and submitted for review and
10 approval its FY 2020 Office of Emergency Management Budget Amendment No. 1,
11 which is incorporated by this reference and which will adjust operational and/or
12 personnel line items; and

13 **WHEREAS,** the FY 2020 Department of Public Safety Office of Emergency Management Budget
14 Amendment No. 1 will not change the total budget amount of \$990,782.89; and

15 **WHEREAS,** the Domestic Affairs and Budget and Finance Committees have reviewed the FY
16 2020 Department of Public Safety Office of Emergency Management Budget
17 Amendment No. 1 and recommend its approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
19 FY 2020 Department of Public Safety Office of Emergency Management Budget
20 Amendment No. 1 effective October 1, 2019 and which will not change the total
21 budget amount of \$990,782.89.

22 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
23 Nation chairperson or any designated official is authorized to administer and
24 expend the FY 2020 Department of Public Safety Office of Emergency
25 Management Budget as amended, provided that any amendments or
26 modifications shall be submitted for prior approval by the Tohono O'odham
27 Legislative Council.

28 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29TH
29 day of APRIL, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;
30 -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
31 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by
32 the Tohono O'odham Nation on January 18, 1986; approved by the Acting Deputy Assistant
33 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
34 18, 1934 (48 Stat.984).
