

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Department of Education Child Care Services Program Child
Care and Development Fund Mandatory Carry Forward Budget)

RESOLUTION NO. 20-140

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation Grants and Contracts Office has identified**
8 **Department of Education Child Care and Development Fund Mandatory Carry**
9 **Forward funds in the amount of \$65,682.66; and**

10 **WHEREAS, the Department of Education Child Care Services Program has prepared and**
11 **submitted for review and approval its FY 2020 Department of Education Child**
12 **Care Services Program Child Care and Development Mandatory Carry Forward**
13 **Budget, which is incorporated by this reference, in the amount of \$65,682.66; and**

14 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
15 **reviewed the FY 2020 Department of Education Child Care Services Program Child**
16 **Care and Development Fund Mandatory Carry Forward Budget and recommend**
17 **its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2020 Department of Education Child Care Services Program Child Care and**
20 **Development Fund Mandatory Carry Forward Budget in the amount of**
21 **\$65,682.66, which shall be funded by the Department of Education Child Care and**
22 **Development Fund.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2020 Department of Education Child Care Services Program Child**
26 **Care and Development Fund Mandatory Carry Forward Budget, provided that any**
27 **amendments or modifications shall be submitted for prior approval by the**
28 **Tohono O'odham Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29TH**
30 **day of APRIL, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
31 **~~0~~ AGAINST; ~~0~~ NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
32 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
33 **the Tohono O'odham Nation on January 18, 1986; approved by the Acting Deputy Assistant**
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
35 **18, 1934 (48 Stat.984).**
