

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Department of Education One Stop Division Public Law
102-477 Budget Amendment No. 1)

RESOLUTION NO. 20-142

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2020 Department of Education One Stop Division Public Law 102-477**
8 **Budget in the amount of \$1,141,040.67 was approved by Resolution No. 19-311;**
9 **and**

10 **WHEREAS, the Department of Education has prepared and submitted for review and**
11 **approval its FY 2020 One Stop Division Public Law 102-477 Budget Amendment No.**
12 **1, which is incorporated by this reference and which will adjust operational**
13 **and/or personnel line items; and**

14 **WHEREAS, the FY 2020 Department of Education One Stop Division Public Law 102-477**
15 **Budget Amendment No. 1 will not change the original budget amount of**
16 **\$1,141,040.67; and**

17 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
18 **reviewed the FY 2020 Department of Education One Stop Division Public Law 102-**
19 **477 Budget Amendment No. 1 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2020 Department of Education One Stop Division Public Law 102-477 Budget**
22 **Amendment No. 1 effective October 1, 2019, which will not change the original**
23 **budget amount of \$1,141,040.67.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
25 **Nation chairperson or any designated official is authorized to administer and**
26 **expend the FY 2020 Department of Education One Stop Division Public Law 102-**
27 **477 Budget as amended, provided that any amendments or modifications shall**
28 **be submitted for prior approval by the Tohono O'odham Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29TH**
30 **day of APRIL, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
31 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
32 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
33 **the Tohono O'odham Nation on January 18, 1986; approved by the Acting Deputy Assistant**
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
35 **18, 1934 (48 Stat.984).**
