

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Department of Education Recreation Division Budget
Amendment No. 1)**

RESOLUTION NO. 20-143

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2020 Department of Education Recreation Division Budget in the amount**
8 **of \$3,014,962.73 was approved by Resolution No. 19-323; and**

9 **WHEREAS, the Department of Education has prepared and submitted for review and**
10 **approval its FY 2020 Recreation Division Budget Amendment No. 1, which is**
11 **incorporated by this reference and which will adjust operational and/or**
12 **personnel line items and change the position title of Director of Recreation to**
13 **Recreation Operations Manager; and**

14 **WHEREAS, the FY 2020 Department of Education Recreation Division Budget Amendment**
15 **No. 1 will not change the total budget amount of \$3,014,962.73; and**

16 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
17 **reviewed the FY 2020 Department of Education Recreation Division Budget**
18 **Amendment No. 1 and recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2020 Department of Education Recreation Division Budget Amendment No. 1**
21 **effective October 1, 2019, which includes adjustments to the operational and/or**
22 **personnel line items and changes the position title of Director of Recreation to**
23 **Recreation Operations Manager and will not change the total budget amount of**
24 **\$3,014,962.73.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
26 **Nation chairperson or any designated official is authorized to administer and**
27 **expend the FY 2020 Department of Education Recreation Division Budget as**
28 **amended, provided that any amendments or modifications shall be submitted**
29 **for prior approval by the Tohono O'odham Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29TH**
31 **day of APRIL, 2020 at a meeting at which a quorum was present with a vote of 2,572.05 FOR;**
32 **603.65 AGAINST; [01] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council**
33 **by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**
34 **by the Tohono O'odham Nation on January 18, 1986; approved by the Acting Deputy Assistant**
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
36 **18, 1934 (48 Stat.984).**
