

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Gu-Vo District Ali Chugk and Pia-Oik Communities
Budget Amendments No. 1)**

RESOLUTION NO. 20-146

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2020 Gu-Vo District Budget in the amount of \$3,574,243.43 was authorized
13 by Gu-Vo District Council Resolution No. GV-19-094 and approved by Legislative
14 Council Resolution No. 19-354 and subsequently amended by Gu-Vo District
15 Council Resolution No. GV-20-016 and approved by Legislative Council
16 Resolution No. 20-116 in the amount of \$3,853,547.32; and

17 **WHEREAS,** by Gu-Vo District Council Resolution No. GV-20-021, the Gu-Vo District has
18 authorized and submitted for review and approval its FY 2020 Gu-Vo District Ali
19 Chugk Community Budget Amendment No. 1 and Pia-Oik Community Budget
20 Amendment No. 1, which are incorporated by these references and which will
21 adjust operational and/or personnel line items; and

22 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2020 Gu-Vo District Ali
23 Chugk Community Budget Amendment No. 1 and the Pia-Oik Community Budget
24 Amendment No. 1 and recommend their approval.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
26 FY 2020 Gu-Vo District Ali Chugk Community Budget Amendment No. 1, which
27 does not change the original budget amount of \$357,424.34 and the Pia-Oik
28 Community Budget Amendment No. 1, which does not change the original budget
29 amount of \$357,424.34.

30 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the FY 2020 Gu-Vo
31 District Ali Chugk and Pia-Oik Communities Budget amendments will not change
32 the FY 2020 Gu-Vo District Budget amount of \$3,853,547.32.

33 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2020 Gu-Vo
34 District Budget as amended shall be managed and expended in accordance with

Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01ST day of MAY, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
