

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2020 Advocate Program Budget Amendment No. 1)**

**RESOLUTION NO. 20-179**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2020 Advocate Program Budget in the amount of \$1,318,215.65 was  
8 approved by Resolution No. 19-323; and

9 **WHEREAS,** the Advocate Program has prepared and submitted for review and approval its FY  
10 2020 Budget Amendment No. 1, which is incorporated by this reference and which  
11 will adjust operational and/or personnel line items; and

12 **WHEREAS,** the FY 2020 Advocate Program Budget Amendment No. 1 will increase the FY 2020  
13 Advocate Program Budget by \$5,000.00 from \$1,318,215.65 to \$1,323,215.65; and


14 **WHEREAS,** the Domestic Affairs and Budget and Finance Committees have reviewed the FY  
15 2020 Advocate Program Budget Amendment No. 1 and recommend its approval.

16 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
17 FY 2020 Advocate Program Budget Amendment No. 1 effective October 1, 2019,  
18 which includes a \$5,000.00 increase from \$1,318,215.65 to \$1,323,215.65 that shall  
19 be a one-time funding by the Nation's general fund.

20 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
21 Nation chairperson or any designated official is authorized to administer and  
22 expend the FY 2020 Advocate Program Budget as amended, provided that any  
23 amendments or modifications shall be submitted for prior approval by the  
24 Tohono O'odham Legislative Council.

25 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup>  
26 day of JUNE, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-  
27 AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by  
28 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by  
29 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
30 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
31 18, 1934 (48 Stat.984).
