

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Sells District Administration and Community
Budgets Amendment No. 3)

RESOLUTION NO. 20-183

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by a
6 treasurer or other authorized officer of the district council who has furnished
7 a surety bond satisfactory to the treasurer of the Tohono O'odham Nation, and
8 all expenditures of these funds shall be by checks signed by such treasurer or
9 other authorized officer and the chairman or vice chairman of the district
10 council.

12 **WHEREAS,** the FY 2020 Sells District Administration and Community Budgets in the amount
13 of \$7,393,075.92 was authorized by Sells District Council Resolution No. SD-74-19
14 and approved by Legislative Council Resolution No. 19-350 and subsequently
15 amended by Sells District Council Resolution No. SD-40-20 and approved by
16 Legislative Council Resolution No. 20-079 and further amended by Sells District
17 Council Resolution No. SD-60-20 and approved by Legislative Council Resolution
18 No. 20-113; and

19 **WHEREAS,** by Sells District Council Resolution No. SD-71-20, the Sells District has authorized
20 and submitted for review and approval its FY 2020 Sells District Administration
21 and Community Budgets Amendment No. 3, which is incorporated by this
22 reference and which will adjust operational and/or personnel line items; and

23 **WHEREAS,** the FY 2020 Sells District Administration and Community Budgets Amendment
24 No. 3 will not change the total budget amount of \$7,393,075.92; and

25 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2020 Sells District
26 Administration and Community Budgets Amendment No. 3 and recommends its
27 approval.

28 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
29 FY 2020 Sells District Administration and Community Budgets Amendment No. 3,
30 which does not change the total budget amount of \$7,393,075.92.

31 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2020 Sells
32 District Administration and Community Budgets as amended shall be managed
33 and expended in accordance with Article IX, Section 7 of the Constitution of the
34 Tohono O'odham Nation and the Nation's laws, provided that any amendments or
