

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2020 Department of Information & Technology Budget Amendment No. 1)**

**RESOLUTION NO. 20-189**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2020 Department of Information & Technology Budget in the amount of**  
8 **\$3,850,058.92 was approved by Resolution No. 19-323; and**

9 **WHEREAS, the Department of Information & Technology has prepared and submitted for**  
10 **review and approval its FY 2020 Budget Amendment No. 1, which is incorporated**  
11 **by this reference and which will adjust operational and/or personnel line items;**  
12 **and**

13 **WHEREAS, the FY 2020 Department of Information & Technology Budget Amendment No. 1**  
14 **will not change the original budget amount of \$3,850,058.92; and**

15 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2020 Department of**  
16 **Information & Technology Budget Amendment No. 1 and recommends its**  
17 **approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
19 **FY 2020 Department of Information & Technology Budget Amendment No. 1,**  
20 **which will not change the original budget amount of \$3,850,058.92.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
22 **Nation chairperson or any designated official is authorized to administer and**  
23 **expend the FY 2020 Department of Information & Technology Budget as**  
24 **amended, provided however, that any amendments or modifications shall be**  
25 **submitted for prior approval by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>**  
27 **day of JUNE, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**  
29 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
32 **18, 1934 (48 Stat.984).**
