

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Tohono O'odham Nation's "2020 Indian Housing Plan for
IHBG Cares Funding")

RESOLUTION NO. 20-192

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power to enact laws "to promote, protect and provide for public health, peace,**
3 **morals education and general welfare of the Tohono O'odham Nation and its**
4 **members" (Constitution, Article VI, Section 1(C)(2)); and**

5 **WHEREAS, the Tohono O'odham Ki:Ki Association ("TOKA") is the Nation's tribally**
6 **designated housing entity in accordance with the Native American Housing**
7 **Assistance and Self-Determination Act of 1996, 25 U.S.C §4101, et seq., P.L. 104-**
8 **330, 110 Stat. 4016 ("NAHASDA"); and**

9 **WHEREAS, to qualify for funds from the Indian Housing Block Grant Program Cares Funding,**
10 **the NAHASDA requires submission of an annual Indian Housing Plan ("IHP") by**
11 **the Indian tribe or by the tribe's designated housing entity (25 U.S.C §4112); and**

12 **WHEREAS, pursuant to Article IX of the Nation's TOKA Ordinance, 18 Tohono O'odham Code,**
13 **Chapter 1, the TOKA shall submit annually to the United States Department of**
14 **Housing and Urban Development's Southwest Area Office of Native American**
15 **Programs ("SWONAP") the Nation's Indian Housing Plan after review and**
16 **approval by Legislative Council resolution (TOKA Ordinance, Article IX, 1.,**
17 **<http://tolc-nsn.org/docs/Title18Ch1.pdf>); and**

18 **WHEREAS, under the direction of the TOKA's executive director, the TOKA prepared and**
19 **submitted the Nation's 2020 Indian Housing Plan for the IHBG Cares Funding to**
20 **TOKA's Board of Directors for review and approval (TOKA Ordinance, Article IX, 1,**
21 **b., ii.); and**

22 **WHEREAS, after approving the Nation's 2020 Indian Housing Plan for IHBG Cares Funding by**
23 **Resolution No. 06-01-20, the TOKA's Board of Directors provided the IHP for IHBG**
24 **Cares funding to the Legislative Housing Committee for review and approval**
25 **(TOKA Ordinance, Article IX, 1, b., iii.); and**

26 **WHEREAS, in accordance with federal regulations promulgated in accordance with the**
27 **CARES Act, the TOKA began expending CARES Funding; and**

28 **WHEREAS, the Legislative Housing Committee recommends approval of the Nation's 2020**
29 **Indian Housing Plan for the IHBG Cares Funding.**

30 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it ratifies**
31 **approval of the Nation's 2020 Indian Housing Plan for IHBG Cares Funding;**
32 **provided that any amendments are subject to Legislative Council review and**
33 **approval.**

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the Nation's Chairperson to sign the certification authorizing submission by the TOKA of the Nation's 2020 Indian Housing Plan for the IHBG Cares Funding.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17th day of JUNE, 2020 at a meeting at which a quorum was present with a vote of 2,134.05 FOR; 797.15 AGAINST; 244.5 [03] NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(c)(2) and Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
