

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2020 Apportionment of Mining Royalties by Equal Distribution)**

**RESOLUTION NO. 20-240**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Tohono O'odham**  
2 **Legislative Council with broad legislative and fiscal powers, including the power**  
3 **to manage any funds within the exclusive control of the Tohono O'odham Nation,**  
4 **including proceeds derived from lands and resources of the Tohono O'odham**  
5 **Nation (Constitution, Article VI, Section 1(d)(2)); and**

6 **WHEREAS, the Tohono O'odham Nation Office of the Treasurer calculated the district**  
7 **apportionment of mining royalties to be \$1,281,771.76 as of July 7, 2020; and**

8 **WHEREAS, the Office of the Treasurer presented to the Legislative Budget and Finance**  
9 **Committee the equal apportionment amounts in accordance with the FY 2020**  
10 **District Mining Allocation Schedule dated July 7, 2020, which is incorporated by**  
11 **this reference and which includes net interest on the royalty amounts; and**

12 **WHEREAS, the district allocation is to be apportioned to separate district accounts and made**  
13 **available for expenditure subject to budgets approved in accordance with Article**  
14 **VI, Section 1(d)(2) and Article IX, Section 7 of the Nation's Constitution.**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it approves**  
16 **and authorizes the FY 2020 Apportionment of Mining Royalties to the districts by**  
17 **Equal distribution in accordance with the FY 2020 District Mining Allocation**  
18 **Schedule.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**  
20 **that such funds shall be made available for expenditure subject to budgets**  
21 **approved in accordance with Article VI, Section 1(d)(2) and Article IX, Section 7 of**  
22 **the Nation's Constitution.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup>**  
24 **day of AUGUST, 2020 at a meeting at which a quorum was present with a vote of 1,896.3 FOR;**  
25 **1,279.4 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council**  
26 **by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
27 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
29 **18, 1934 (48 Stat.984).**
