

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Department of Health and Human Services Self-Governance Budgets)

RESOLUTION NO. 20-252

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
8 review and approval its FY 2021 Self-Governance Budgets for the period
9 beginning October 1, 2020 and ending on September 30, 2021 (collectively "FY
10 2021 Department of Health and Human Services Self-Governance Budgets"),
11 which are provided below and incorporated by this reference, in the total amount
12 of \$6,868,661.41 to be funded by the Self-Governance Funding Agreement; and

13 **WHEREAS,** the following budgets in the amount of \$6,868,661.41 have been prepared as
14 follows:

21 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
22 reviewed and the FY 2021 Department of Health and Human Services Self-
23 Governance Budgets and recommend their approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
25 FY 2021 Department of Health and Human Services Self-Governance Budgets
26 effective October 1, 2020 in the total amount of \$6,868,661.41, which shall be
27 funded by the Self-Governance Funding Agreement.

28 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the Tohono
29 O'odham Nation chairperson or any designated official is authorized to negotiate
30 and execute amendments to the Self-Governance Funding Agreement with the
31 Indian Health Service for the maximum allowable funding.

32 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
33 Nation chairperson or any designated official is authorized to administer and
34 expend the FY 2021 Department of Health and Human Services Self Governance

Budgets, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH day of SEPTEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


