

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Initiative Administrative Budgets)

RESOLUTION NO. 20-253

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, pursuant to Initiative IN-01-97, the Nation provides for the annual administrative**
8 **cost of implementing the provisions of the Initiative; and**

9 **WHEREAS, the Executive Branch has prepared and submitted for review and approval its FY**
10 **2021 Initiative Administrative Budgets, which are incorporated by this reference,**
11 **in the amount of \$1,787,607.51 to be funded from the Desert Diamond Savings**
12 **Account:**

20 **WHEREAS, the Rules and Budget and Finance Committees have reviewed the FY 2021**
21 **Initiative Administrative Budgets and recommend their approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
23 **FY 2021 Initiative Administrative Budgets effective October 1, 2020 in the amount**
24 **of \$1,787,607.51, which shall be funded by the Desert Diamond Savings Account.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
26 **Nation chairperson or any designated official is authorized to administer and**
27 **expend the FY 2021 Initiative Administrative Budgets, provided that any**
28 **amendments or modifications shall be submitted for prior approval by the**
29 **Tohono O'odham Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
31 **day of SEPTEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
32 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
33 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
34 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
36 **18, 1934 (48 Stat.984).**
