

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Department of Public Safety Police Department, U.S. Department of Justice, Office of Community Oriented Policing Services Hiring Program Homeland Security Grant Budget)

RESOLUTION NO. 20-267

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Public Safety has prepared and submitted for review and**
8 **approval its FY 2021 Department of Public Safety Police Department, U.S.**
9 **Department of Justice, Office of Community Oriented Policing Services Hiring**
10 **Program Homeland Security Grant Budget, which is incorporated by this**
11 **reference, in the amount of \$125,000.00 to be funded by the Nation's general fund**
12 **pending reimbursement by the grantor, the U.S. Department of Justice, and cost**
13 **shared with the FY 2021 Department of Public Safety Police Department Law**
14 **Enforcement Budget; and**

15 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**
16 **2021 Department of Public Safety Police Department, U.S. Department of Justice,**
17 **Office of Community Oriented Policing Services Hiring Program Homeland**
18 **Security Grant Budget and recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2021 Department of Public Safety Police Department, U.S. Department of**
21 **Justice, Office of Community Oriented Policing Services Hiring Program**
22 **Homeland Security Grant Budget effective September 1, 2020 in the amount of**
23 **\$125,000.00 which shall be funded by the Nation's general fund pending**
24 **reimbursement by the grantor, the U.S. Department of Justice, and cost shared**
25 **with the FY 2021 Department of Public Safety Police Department Law**
26 **Enforcement Budget.**


27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
28 **Nation chairperson or any designated official is authorized to administer and**
29 **expend the FY 2021 Department of Public Safety Police Department, U.S.**
30 **Department of Justice, Office of Community Oriented Policing Services Hiring**
31 **Program Homeland Security Grant Budget, provided that any amendments or**
32 **modifications shall be submitted for prior approval by the Tohono O'odham**
33 **Legislative Council.**
