

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2021 Department of Health and Human Services Division of Behavioral**  
**Health Substance Abuse Mental Health Services Administration Native**  
**Connections Grant Budget)**

**RESOLUTION NO. 20-277**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation received an award notice in the amount of**  
8 **\$200,000.00 for year five of the five-year funding cycle for the budget period of**  
9 **September 30, 2020 through September 29, 2021, from the Substance Abuse**  
10 **Mental Health Services Administration ("SAMHSA") Native Connections Grant;**  
11 **and**

12 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**  
13 **review and approval its FY 2021 Division of Behavioral Health SAMHSA Native**  
14 **Connections Grant Budget, which is incorporated by this reference, in the**  
15 **amount of \$200,000.00 to be funded by the Nation's general fund pending**  
16 **reimbursement by the grantor, the Substance Abuse Mental Health Services**  
17 **Administration; and**

18 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
19 **reviewed the FY 2021 Department of Health and Human Services Division of**  
20 **Behavioral Health SAMHSA Native Connections Grant Budget and recommend its**  
21 **approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
23 **FY 2021 Department of Health and Human Services Division of Behavioral Health**  
24 **Substance Abuse Mental Health Services Administration Native Connections**  
25 **Grant Budget effective September 30, 2020 in the amount of \$200,000.00, which**  
26 **shall be funded by the Nation's general fund pending reimbursement by the**  
27 **grantor, the Substance Abuse Mental Health Services Administration.**

28 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
29 **Nation chairperson or any designated official is authorized to administer and**  
30 **expend the FY 2021 Department of Health and Human Services Division of**  
31 **Behavioral Health Substance Abuse Mental Health Services Administration**  
32 **Native Connections Grant Budget, provided that any amendments or**

1 modifications shall be submitted for prior approval by the Tohono O'odham  
2 Legislative Council.

4 day of SEPTEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;  
5 -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by  
6 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by  
7 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
8 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
9 18, 1934 (48 Stat.984).
