5	WHEREAS,	Articles VI and VII of the Nation's Enrollment Ordinance provide that the
6		Enrollment Committee is responsible for reviewing enrollment applications and
7		making recommendations to the Legislative Council regarding the eligibility of
8		applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and
9	WHEREAS,	Article VIII of the Nation's Eurollment Ordinance provides that the Tohono
10		O'odham Legislative Council shall determine whether an application is approved
11		for membership and its determination, along with the resolution number and
12		date of enactment, shall be provided to the applicant; and
13	WHEREAS,	the Enrollment Program has determined that a number of resolutions approving
14		membership and adoption applications misspelled or incorrectly listed the
15		names of members; and
16	WHEREAS,	the Enrollment Program therefore recommends that Resolution Nos. 74-81, 99-
17		475, 01-416, 02-332, 03-301, 03-339, 03-463, 04-659 and 07-500 be amended to
18		reflect the correct name for the members identified in the September 2020
19		Corrected Enrollment Resolution Summary, which is incorporated by this
20		reference.
21	NOW, THERE	FORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution
22		Nos. 74-81, 99-475, 01-416, 02-332, 03-301, 03-339, 03-463, 04-659 and 07-500 are
