

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Department of Health and Human Services Division of Behavioral Health SAMHSA TBH COVID-19 Budget)

RESOLUTION NO. 20-297

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
8 **review and approval its FY 2021 Division of Behavioral Health SAMHSA TBH**
9 **COVID-19 Budget, which is incorporated by this reference, in the amount of**
10 **\$97,402.00, which shall be funded by the Nation's general fund pending**
11 **reimbursement by the grantor, the Department of Health and Human Services**
12 **Substance Abuse and Mental Health Services Administration ("SAMHSA"); and**

13 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
14 **reviewed the FY 2021 Department of Health and Human Services Division of**
15 **Behavioral Health SAMHSA TBH COVID-19 Budget and recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2021 Department of Health and Human Services Division of Behavioral Health**
18 **SAMHSA TBH COVID-19 Budget effective May 15, 2020 through May 14, 2021 in the**
19 **amount of \$97,402.00, which shall be funded by the Nation's general fund pending**
20 **reimbursement by the grantor, the Department of Health and Human Services**
21 **SAMHSA.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Nation chairperson or any designated official is authorized to administer and**
24 **expend the FY 2021 Department of Health and Human Services Division of**
25 **Behavioral Health SAMHSA TBH COVID-19 Budget, provided that any**
26 **amendments or modifications shall be submitted for prior approval by the**
27 **Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH**
29 **day of SEPTEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
30 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**
