

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Chukut Kuk District Tecolote Community Budget Amendment
No. 2, FY 2020 Chukut Kuk District San Miguel Community Budget Amendment
No. 1 and Chukut Kuk District Budget Amendments No. 5 and No. 6)**

RESOLUTION NO. 20-302

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only
6 by a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2020 Chukut Kuk District Budget in the amount of \$2,129,448.90 was
13 authorized by Chukut Kuk District Council Resolution No. 2019-39 and approved
14 by Legislative Council Resolution No. 19-352, and subsequently amended by
15 Resolution No. 19-461 in the amount of \$2,405,912.32, Resolution No. 20-024 in the
16 amount of \$2,433,768.02, Resolution No. 20-071 in the amount of \$2,433,768.02,
17 and further amended by Resolution No. 20-114 in the amount of \$2,680,127.62;

19 **WHEREAS,** by Chukut Kuk District Council Resolution No. 2020-18 and Resolution No. 2020-
20 19, the Chukut Kuk District has authorized and submitted for review and
21 approval its FY 2020 Tecolote Community Budget Amendment No. 2 and FY 2020
22 Chukut Kuk District Budget Amendment No. 5, which are incorporated by these
23 references and which will adjust operational and/or personnel line items; and

24 **WHEREAS,** by Chukut Kuk District Council Resolution No. 2020-22 and Resolution No. 2020-
25 23, the Chukut Kuk District has authorized and submitted for review and
26 approval its FY 2020 San Miguel Community Budget Amendment No. 1 and FY 2020
27 Chukut Kuk District Budget Amendment No. 6, which are incorporated by these
28 reference and which will adjust operational and/or personnel line items; and

29 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2020 Tecolote
30 Community Budget Amendment No. 2, the FY 2020 San Miguel Community Budget
31 Amendment No. 1 and the FY 2020 Chukut Kuk District Budget Amendments No. 5
32 and No. 6 and recommends their approval.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves:

- (1) FY 2020 Chukut Kuk District Tecolote Budget Amendment No. 2 which includes a \$25,000.00 increase from \$126,359.60 to \$151,359.60 that shall be funded by FY 2009 carryover funds;**
- (2) FY 2020 Chukut Kuk District Budget Amendment No. 5 adjusting identified funds in the amount of \$15,500.00 to various line items to cover expenditures and anticipated costs and which incorporates the Tecolote Community Budget Amendment No. 2 which will increase the budget by \$25,000.00 from \$2,680,127.62 to \$2,705,127.62;**
- (3) FY 2020 Chukut Kuk District San Miguel Community Budget Amendment No. 1, adjusting \$14,898.00 to various line items to cover expenditures and anticipated costs and amending budget justification to Line Item 750-Capital Equipment, which will not change budget amount; and**
- (4) FY 2020 Chukut Kuk District Budget Amendment No. 6 incorporating the FY 2020 San Miguel Community Budget Amendment No. 1 in the amount of \$14,898.00 which does not change the total budget amount of \$2,705,127.62.**

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2020 Chukut Kuk District Budget as amended shall be managed and expended in accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH day of SEPTEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; ~~0~~ AGAINST; ~~0~~ NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
