

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 1 to the Intergovernmental Agreement between
Arizona Health Care Cost Containment Systems and the Tohono O'odham Nation)**

RESOLUTION NO. 20-313

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power to "consult, negotiate and conclude agreements and contracts on**
3 **behalf of the Tohono O'odham Nation with Federal, State and local governments**
4 **and other Indian tribes or their departments, agencies, or political subdivisions,**
5 **or with private persons or organizations on all matters within the authority of the**
6 **Tohono O'odham Council." (Constitution, Article VI, Section 1(f)); and**

7 **WHEREAS, the Intergovernmental Agreement ("IGA") between Arizona Health Care Cost**
8 **Containment Systems ("AHCCCS") and Tohono O'odham Nation ("Nation") was**
9 **approved by Legislative Council Resolution No. 17-515; and**

10 **WHEREAS, the Nation has provided Arizona Long Term Care Systems ("ALTCs") case**
11 **management services since June 1996 and is compensated from the State of**
12 **Arizona for the services; and**

13 **WHEREAS, Amendment No. 1 to the IGA, which is incorporated by this reference, extends the**
14 **term of the IGA for two years beginning July 1, 2020 through June 30, 2022 and**
15 **identifies an AHCCCS contact person; and**

16 **WHEREAS, the Health and Human Services Committee has reviewed the Amendment No. 1 to**
17 **the IGA between Arizona Health Care Cost Containment Systems and the Tohono**
18 **O'odham Nation and recommends its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **Amendment No. 1 to the Intergovernmental Agreement between Arizona Health**
21 **Care Cost Containment Systems and the Tohono O'odham Nation effective July 1,**
22 **2020.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **execute the Intergovernmental Agreement between Arizona Health Care Cost**
26 **Containment Systems and Tohono O'odham Nation, provided that any**
27 **amendments shall be submitted for prior approval by the Tohono O'odham**
28 **Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH**
30 **day of SEPTEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
31 **-0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
32 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
33 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
34 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
